## PRODUCT DESCRIPTION

Perfume-free and dye-free general purpose skin protection cream containing Eucoriol® astringent agent. Helps improve grip in damp environments and stops skin softening under gloves.

## WHERE TO USE

Suitable for most workplaces to protect against moderate to heavy exposure to oil-based and water-based substances (such as oil, grease, lubricants and detergents) where gloves are worn intermittently.

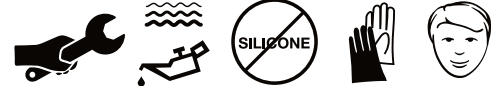

## INSTRUCTIONS FOR USE

### Before Working:

- Apply 1ml to clean and dry skin before starting each work period and after washing hands
- Rub on all areas of the hands, including between the fingers and around the fingernails

Keep out of reach of children. If contact occurs with eyes, rinse with water. If swallowed, get medical help or contact a poison control center immediately.

## SHELF LIFE

This product has a shelf life of at least 30 months from the date of manufacture when stored unopened at room temperature. For shelf life after opening: see indication on packaging.

## SUITABLE FOR USE IN FOOD HANDLING

The use of Stokoderm® Grip PURE as per usage instructions, does not influence the quality and safety of foodstuffs.

The product has been assessed using the HACCP hazard analysis methodology. The following critical control points were identified and are controlled as follows -

1. Impact on smell and taste of foodstuffs - The formulation has been independently tested according to 'Sensory Analysis - Methodology - Triangle Test BS EN ISO 4120:2007' and proven to not have the potential to taint food.
2. Possible toxic effects of ingredients - An independent oral toxicological evaluation was performed and concluded that any foodstuffs which may contain trace amounts of the product, are unlikely to cause any adverse toxicological effects.

## CERTIFICATIONS

### ECARF Seal of Quality

The European Centre for Allergy Research Foundation (ECARF) awards the ECARF-quality seal to allergy-friendly products.

## INGREDIENTS

AQUA (WATER), ETHYLHEXYLSTEARATE, GLYCERYL STEARATE SE, GLYCERIN, CETEARYL ALCOHOL, SODIUM BISCHLOROPHENYL SULFAMINE, (EUCORIOL®) ISOPROPYL PALMITATE, GLYCOL DISTEARATE, XANTHAN GUM, CETEARETH-6, CETEARETH-25, 1,2-HEXANEDIOL, CAPRYLYL GLYCOL, TROPOLONE.

## QUALITY ASSURANCE

SC Johnson Professional products are manufactured in facilities which follow Good Manufacturing Practice (GMP) and/or Cosmetic GMP requirements.

All raw materials used for production undergo a thorough quality control process before being used for manufacturing in SC Johnson Professional's high quality products.

All finished goods are subject to intensive quality testing before being shipped out to our customers.

## PRODUCT SAFETY ASSURANCE

### Skin Compatibility Test

Clinical dermatological tests have been conducted to assess the skin compatibility of the product using voluntary test persons in enclosed and repeat application models. These tests, as well as in practical use, have proven that the product has very good skin compatibility. Skin compatibility expert reports are available upon request.

### Toxicological Approval

The product has been independently assessed for human toxicity and product stability. It is declared safe for intended use, meeting all relevant regulatory requirements.

## COMPATIBILITY TESTS

### Glove Compatibility

In independent testing, the use of Stokoderm® Grip PURE in combination with reputable latex, vinyl and nitrile gloves does not have any deleterious effect on the glove tensile properties using BS EN 455-2:2009 test methodology.

### Rubber Production Process Compatibility

In testing conducted by the Deutsches Institut für Kautschuktechnologie (DIK) in accordance with DIN EN ISO/IEC 17025, the use of Stokoderm® Grip PURE in rubber production process does not influence the cohesive strength of rubber.

## EFFICACY TESTS

### Barrier Property Test

The protective action of Stokoderm® Grip PURE formulation was tested using the modified Tandem Repetitive Occlusive Irritation Test (TRIT), a modern skin physiology in vivo test. The model irritants are occlusively applied to the skin twice a day for 30 minutes over a period of four days. The resulting skin irritation is defined and compared with the help of the visual score (VS); the resulting barrier damage with help of the transepidermal water loss (TEWL). Stokoderm® Grip Pure significantly reduces the irritation effect of the test irritants compared to unprotected skin.
