PRODUCT SAFETY ASSURANCE

Skin Compatibility Test

Independent dermatological tests conducted to assess the skin compatibility of the product using voluntary test persons in occlusive, 48 consecutive hour application models, shows the product to be non-irritating in use.

Toxicological Approval

The product has been assessed by an independent toxicologist and has been declared to be safe for use on hands, face and whole body of adults aged 16 and above.

INGREDIENTS

Aqua (Water), Isoamyl Cocoate, Caprylic/Capric Triglyceride, Glycerin, Polyglyceryl-3 Dicitrate/Stearate, Myristyl Myristate, Hydroxyacetophenone, Allantoin, Creatine, Cera Microcristallina, Paraffin, Hydrogenated Castor Oil, Acrylates/C10-30 Alkyl Acrylate Crosspolymer, Stearyl Alcohol, Sodium Hydroxide, Parfum (Fragrance).

COMPATIBILITY TESTS

Glove Compatibility

In independent testing, the use of SBS® 40 cream in combination with reputable latex, vinyl and nitrile gloves does not have any deleterious effect on the glove tensile properties using BS EN 455-2:2009 test methodology.

Rubber Production Process Compatibility

In testing conducted by the Deutsches Institut für Kautschuktechnologie (DIK) in accordance with DIN EN ISO/IEC 17025, the use of SBS® 40 cream in rubber production does not influence the cohesive strength of rubber.

Sanitizer Compatibility Test

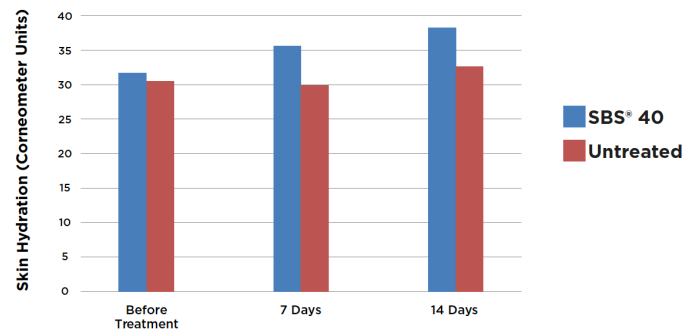
The compatibility of SBS® 40 cream with alcohol-based hand sanitizers was tested using a modified EN13727 test protocol. Results show that SBS® 40 cream does not negatively affect the efficacy of alcohol based hand sanitizers against *Ps aeruginosa*, *E coli*, *S aureus* and *E. hirae*.

EFFICACY TESTS

Skin Hydration Test

During a 2 week application period, the hydrating effect of SBS® 40 cream was tested using 15 panelists. Results show that after one week application of SBS® 40 cream, the skin hydration level had risen by 6.5% and after 2 weeks it had risen by 8.4%. SBS® 40 cream enhances skin moisture content when used as directed and as part of a comprehensive skin care regime.
