Enriched skin conditioning cream designed for professional use with high levels of moisturisers to care for dry to very dry skin. Lightly perfumed.

For use in industrial and healthcare environments.

Dry to very dry skin.

INSTRUCTIONS FOR USE

- Apply 1ml to clean and dry skin prior to extended breaks and at the end of the working day.
- Rub on all areas of the hands, including between the fingers and around the fingernails.
- Can also be used on the face and body.
- Apply regularly as part of a skin care routine.

PRODUCT SAFETY ASSURANCE

Product Safety Assessment

The product has been assessed by an independent toxicologist and is declared safe for intended use on hands and body of adults and children above 3 years old when used as directed, meeting all relevant regulatory requirements.

Skin Compatibility Test

Independent dermatological tests conducted to assess the skin compatibility of the product using voluntary test persons in occlusive, 48 consecutive hour application models, shows the product to be nonirritating in use.

COMPATIBILITY TESTS

Rubber Production Process Compatibility

In testing conducted by the Deutsches Institut für Kautschuktechnologie (DIK) in accordance with DIN EN ISO/IEC 17025, the use of Stokolan® CLASSIC cream in rubber production process does not influence the cohesive strength of rubber.

Sanitiser Compatibility Test

The compatibility of Stokolan® CLASSIC cream with alcohol-based hand sanitisers was tested using a modified EN13727 test protocol. Results show that Stokolan® CLASSIC cream does not negatively affect the efficacy of alcohol based hand sanitisers against *Ps aeruginosa*, *E coli*, *S aureus* and *E hirae*.

INGREDIENTS

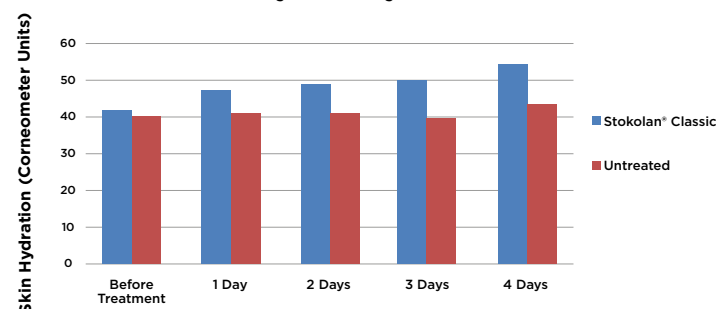
AQUA (WATER), PARAFFINUM LIQUIDUM, GLYCERIN, STEARIC ACID, GLYCERYL STEARATE SE, LANOLIN, CETEARYL ALCOHOL, UREA, PARFUM (FRAGRANCE), POTASSIUM HYDROXIDE, METHYLPARABEN, DEHYDROACETIC ACID, PROPYLPARABEN, POTASSIUM SORBATE, LINALYL ACETATE, GERANYL ACETATE, TERPINEOL.

EFFICACY TESTS

Skin Hydration Test

The moisturising properties of Stokolan® CLASSIC cream were assessed via application of the product twice daily at an interval of approx. 5 hours to the forearm skin of healthy volunteers over a 4 day test period. The starting values for the skin moisture were determined in the morning by means of the Corneometer® and before the first application and then again on the morning of the subsequent day.

4 Day Skin Hydration Test

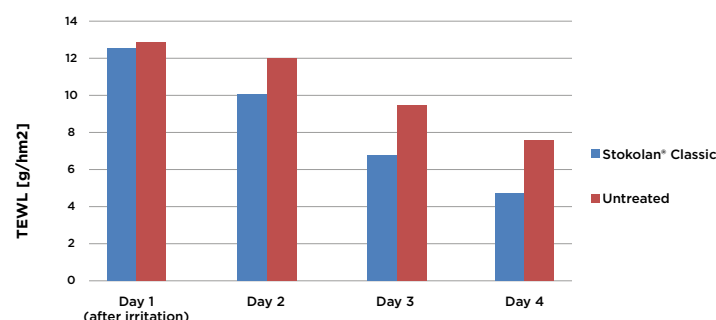


Results show that under repeated usage conditions, Stokolan® CLASSIC cream provides a continuous increase in the hydration of the skin by 31.7% over untreated skin. This demonstrates that the skin moisture is clearly improved by Stokolan® CLASSIC cream when used regularly.

Skin Barrier Restore Test

Skin barrier testing was performed on the forearm skin of healthy volunteers. Skin damage was induced by occlusive application of 0.5% sodium lauryl sulphate solution over a 12 hour period. The initial damage of the skin was classified by means of two parameters: a) visual inspection (irritation score according to Frosch and Kligman) and b) trans-epidermal water loss (TEWL as an indicator of the skin barrier quality). Stokolan® CLASSIC cream was then applied twice daily at an interval of approx. 5-6 hours over a 4 day test period.

4 Day Skin Barrier Restore Test



Results show that under repeated usage conditions, both the visually apparent damage and the barrier damage characterised by the TEWL is reduced compared to untreated skin. This demonstrates that when used regularly, Stokolan® CLASSIC cream supports restoration of the skin's own natural barrier function.

NB: After-work skin care creams help to maintain the skin in good condition keeping it strong and healthy, avoiding dryness. Using care creams is an important element in skin care best practice.
