Perfume-free, dye-free liquid surgical scrub featuring 2% Chlorhexidine Gluconate (CHG).

WHERE TO USE

Ideal for use in healthcare settings where a highly effective surgical scrub or soap is needed.

INSTRUCTIONS FOR USE

For Hospital and Professional Use Only.

Directions

Use with care on premature infants or infants under 2 months of age. This product may cause irritation or chemical burns.

Surgical hand scrub:

- Wet hands and forearms with water
- Scrub for 3 minutes with about 5 mL of product and a wet brush paying close attention to the nails, cuticles, and interdigital spaces
- A separate nail cleaner may be used
- Rinse thoroughly
- Scrub for an additional 3 minutes with 5 mL of product and rinse under running water
- Dry thoroughly

Healthcare personnel

handwash:

- Wet hands with water
- Dispense about 5 mL of product into cupped hands and wash in a vigorous manner for 15 seconds
- Rinse and dry thoroughly

Patient preoperative skin

preparation:

- Apply product liberally to surgical site and swab for at least 2 minutes and dry with a sterile towel
- Repeat procedure for an additional 2 minutes and dry with a sterile towel

Skin wound and general skin

cleaning:

- Thoroughly rinse the area to be cleaned with water
- Apply the minimum amount of product necessary to cover the skin or wound area and wash gently
- Rinse again thoroughly

- repeated general skin cleansing of large body areas should not be done except when advised by a health care provider
