Directions for Use:

Read and follow all directions and precautions on this product label.

Shake well before using.

- Point spray nozzle away from face and press button, holding container as upright as possible.
- Spray into the air with a sweeping motion, keeping about three feet from interior walls, fabrics and furniture, until the room is thoroughly misted.
- For Wasps, Hornets, Yellow Jackets, and Asian Lady Beetles: Spray directly at stray insects that enter the building.
- Do not remain in treated area. Keep room closed for two hours.
- Ventilate room thoroughly before re-entry.
- To reduce annoyance of these insects, spray area when air is calm for best results.

Storage and Disposal:

Storage: Store in a cool dry place away from heat or flame in an area inaccessible to children.
