- Rotational rubbing of left thumb clasped in right palm and vice versa
- Rotational rubbing, backwards and forwards with clasped fingers of right hand in left palm and vice versa
- Once dry, your hands are sanitized

Skin Compatibility Test

Clinical dermatological tests have been conducted to assess the skin compatibility of the product using voluntary test persons in enclosed and repeat application models. These tests, as well as in practical use, have proven that the product have very good skin compatibility.
